MEETING MINUTES REVIEW AND APPROVAL:

Carl Blount made a motion to approve the minutes from May 05, 2025, with a second from Randy Halstead. The Committee voted unanimously to approve these minutes.

DISCUSSION

The Committee reviewed round 1 voting results numbers without the project names.

TSAC VOTES & COMMITTEE ACTIONS:

Chair Alex Sams recommended removing the projects with only 0 or 1 votes. The Committee voted 8 to 1. The recommendation was approved.

Bryan Gomez made a motion to remove all projects that received only 2 votes, with a second from Kristen Morales. The Committee votes 4 to 5. The motion was not approved.

Jeb Bradberry made a motion to move project 34, Milledge Makeover, that received 11 votes forward to the final recommended project list, with a second from Carl Blount. The Committee voted unanimously to approve.

William Breeding made a motion to move forward the projects that received 9, with the exception of project 19, to the final recommended project list, with a second from Carl Blount. The Committee voted 4 to 6 the motion was not approved.
