FY26-30 Consolidated Plan

- Five-year plan of needs assessment, a resource review and a gaps analysis
- Includes a strategic plan of prioritized goals and strategies and an annual action plan
- All CDBG projects must meet one of the approved ConPlan goals and National Objectives
- New Goals for FY26-30
 - Affordable Housing Development and Redevelopment
 - Public Services
 - Economic Development
 - Public Facilities and Improvements

FY26 CDBG Applications Discussion

- **Public Services**
 - **Minimum award of \$30,000 and a 25% cash match requirement**
 - **15% cap of the total annual CDBG budget and projects cannot be carried forward**
 - Reasons given for disqualified/ineligible applications
 - No comments or concerns on combined ratings scores
 - HCD Staff will come up with funding recommendations for M&C and send to VC for approval
- **Affordable Housing**
 - No comments or concerns on combined ratings scores
- **Economic Development**
 - CBDO (Community Based Development Organization) provides Public Services activities to a specific NRSA (Neighborhood Revitalization Strategy Area) - EADC is the only CBDO in Athens
 - Alison - 2 Questions:
 - What is in the ACC Gov ConPlan to encourage agencies to become CBDOs?
 - Marqueta - Nothing in the ConPlan, but we do try to educate the community on what a CBDO is
 - There are hindrances that may make becoming a CBDO not worth the effort for many agencies
 - Is a reduction of dollars or a non-vote for an agency from multiple VC members noted when recommendations are presented to M&C?
