AIRPORT OVERLAY) FOR TWO PARCELS OF LAND LOCATED AT 1580 AND 1590 LEXINGTON ROAD;
AND FOR OTHER PURPOSES.**

The Commission of Athens-Clarke County, Georgia hereby ordains as follows:

SECTION 1. The current C-G (A) (Commercial-General, Airport Overlay) District is hereby amended to provide for special use approval of drive-through restaurant. The affected parcels of land comprise approximately 1.17 acres, are located at 1580 and 1590 Lexington Road, and are known as tax parcel numbers 174B1 B009 and 174B1 B009A on the Athens-Clarke County Tax Map, being on file and available for public inspection in the office of the Athens-Clarke County Planning Department, 120 West Dougherty Street, Athens, Georgia. The date of this amendment to the Official Zoning Map as shown by Attachment A hereto shall be noted on the Official Zoning Map in the office of the Clerk of Commission and duly noted in the minutes of the Commission meeting.
