

In February 2024, the campaign put the \$5,000 from cash on hand into a CD at Synovus Bank, the same bank where the campaign account is located. The CD was not listed on previous reports in 2024 as an investment. The \$5,000 was included as cash and included in the net balance of each report. The \$236.63 in interest was not credited until February 2025. All interest is listed on this report as investment income. In February 2025, the entire cd was renewed and is now listed as an expense on this report. It will be listed as an investment in future reports.
