**SUBJECT:** Acceptance of Grant Award from Riverview Foundation for Cook's Trail

---

**EXECUTIVE SUMMARY:** This agenda report requests acceptance of grant funding to secure engineering services for Phase 1 of the Cook's Trail redesign project. This phase will focus on developing a rerouted alignment that will allow the southern section to reopen at project completion while strengthening the trail's overall durability and resilience from flooding.

**PURPOSE:**

To request that the Mayor and Commission:

- a. Approve the acceptance of \$100,000 grant award;
- b. Adopt a budget amendment ordinance (**Attachment #1**);
- c. Authorize the Mayor and relevant staff to execute all related grant documents, agreements, and contracts.

---

**HISTORY:**

1. In 1954, the Watershed and Flood Prevention Act was passed by Congress, enabling the Soil Conservation Service (SCS) to partner with localities to create watershed management plans and build flood control structures.
2. In 1964, an application by Clarke, Jackson, and Madison counties for a watershed project involving 28,000 acres was approved by the Soil and Water Conservation Committee. This project would create a flood-control lake on the border between Clarke and Jackson counties, named Lake Chapman, in honor of Cecil W. Chapman, a retired state conservationist who championed this project.
3. In 1973, a resident group selected land and formed the Northeast Georgia Nature Center.
4. In 1977, the dam project was completed. The dam formed a flood-control lake with a

normal pool of 260 acres and is designed to double in volume during flood events, swelling the lake to as much as 400 acres to slow flood waters and protect both Sandy Creek and Athens.

5. In 1977, the first building, known as Fireside Classroom, was completed.
6. In 1981, the Nature Center board deeded the property to the county.
7. On October 15, 1981, Sandy Creek Park opened to the public.
8. In 1981, Sandy Creek Nature Center made a pre-application to the Georgia Department of Natural Resources to acquire grants for a "Greenway", which would connect the nature center and the Sandy Creek Park.
9. In 1990, the name of the Nature Center was officially changed to Sandy Creek Nature Center. Sandy Creek Greenway trail, now called Cook's Trail, connected the Nature Center to Sandy Creek Park.
10. In 2013, a boardwalk was constructed to join the two hiking trails on each side of the lake over a section of the wetland acquired in 2000. This boardwalk completed what is now known as Lakeside Trail, closing the loop originally envisioned in the park's design.
11. On December 6, 2018, Cook's Trail was closed temporarily due to flooding. This was the same incident that impacted the East Campus Connector construction.
12. On April 20, 2019, the South portion of Cook's Trail was closed permanently due to severe flooding, which activated the emergency spillway at Sandy Creek Park.
13. On August 18, 2019, a boundary survey for the Northern portion of the trail was completed.
14. In 2020, the Riverview Foundation provided \$68,000 to Sandy Creek Nature Center, Inc., to renovate the exterior restroom behind the Nature Center.
15. In the fall of 2025, the Leisure Services Department was invited to submit a proposal for the Cook's Trail project.
16. On October 23, 2025, Leisure Services staff were notified of a \$100,000 award supporting the Cook's Trail Project.

---

#### **FACTS & ISSUES:**

1. Cook's Trail, once a beloved 4.1-mile natural surface pathway, linked Sandy Creek Nature Center to Sandy Creek Park and served as Athens' original Greenway. Severe flooding in 2019 led to the permanent closure of the southern portion of the trail, severing a vital connection for the community.

2. For decades, the 4.1-mile natural surface path provided a scenic route through wetlands, forests, and along the Oxbow Lake, connecting families, hikers, and school groups with the natural beauty of Athens.
3. As storms intensified and flooding became more frequent, the southern portion of the trail suffered repeated damage. Temporary closures began in 2016, but by 2019, flooding forced its permanent closure. What was once a beloved link in Athens' Greenway network now sits inaccessible, awaiting a resilient redesign to ensure its next chapter.
4. Over the years, Leisure Services has requested that Cook's Trail be considered for funding via TSPLOST 2018, SPLOST 2020, and TSPLOST 2026. These requests could not be funded.
5. The Riverview Foundation Grant seeks to enrich the livability and stewardship of select communities and natural areas. The foundation's grant-making priorities include the performing arts, habitat and wildlife conservation, parks and greenways, and other projects of interest to the Trustees.
6. Leisure Services staff met with the Executive Director of the Riverview Foundation during the fall of 2025 to gauge interest in supporting the project. After the discussion, the department was invited to submit a proposal for the Cook's Trail project. The department was notified of Riverview's intent to fund the project.
7. With Riverview's support, Leisure Services will start developing the engineering plans to reroute and reopen two miles of trail along higher ground, creating a flood-resilient design that ensures long-term sustainability. This investment will lay the groundwork for restoring a treasured community resource that enhances public health, fosters neighborhood connections, and preserves the natural beauty of Athens for future generations.
8. The proposed re-route of Cook's Trail will follow the contours through the east side of the property, located mostly above the floodplain. The proposed concept alignment would reduce the amount of built structure, such as boardwalks, and consolidate any remaining boardwalks and bridges into a centralized area.
9. The redesign and reopening of Cook's Trail will impact numerous neighborhoods and communities, including those with Low to Moderate Incomes (HUD, 2025).
10. These recommendations support the following ACCGov FY26-28 Strategic Plan Goals, Strategies, and/or Initiatives:
  - Built and Natural Infrastructure Goal, Strategy A: *Adequately plan infrastructure to support our community in the future*

- Initiative 6.A.3: *Use department master plan to address service gaps and maintain existing parks, amenities, and services*

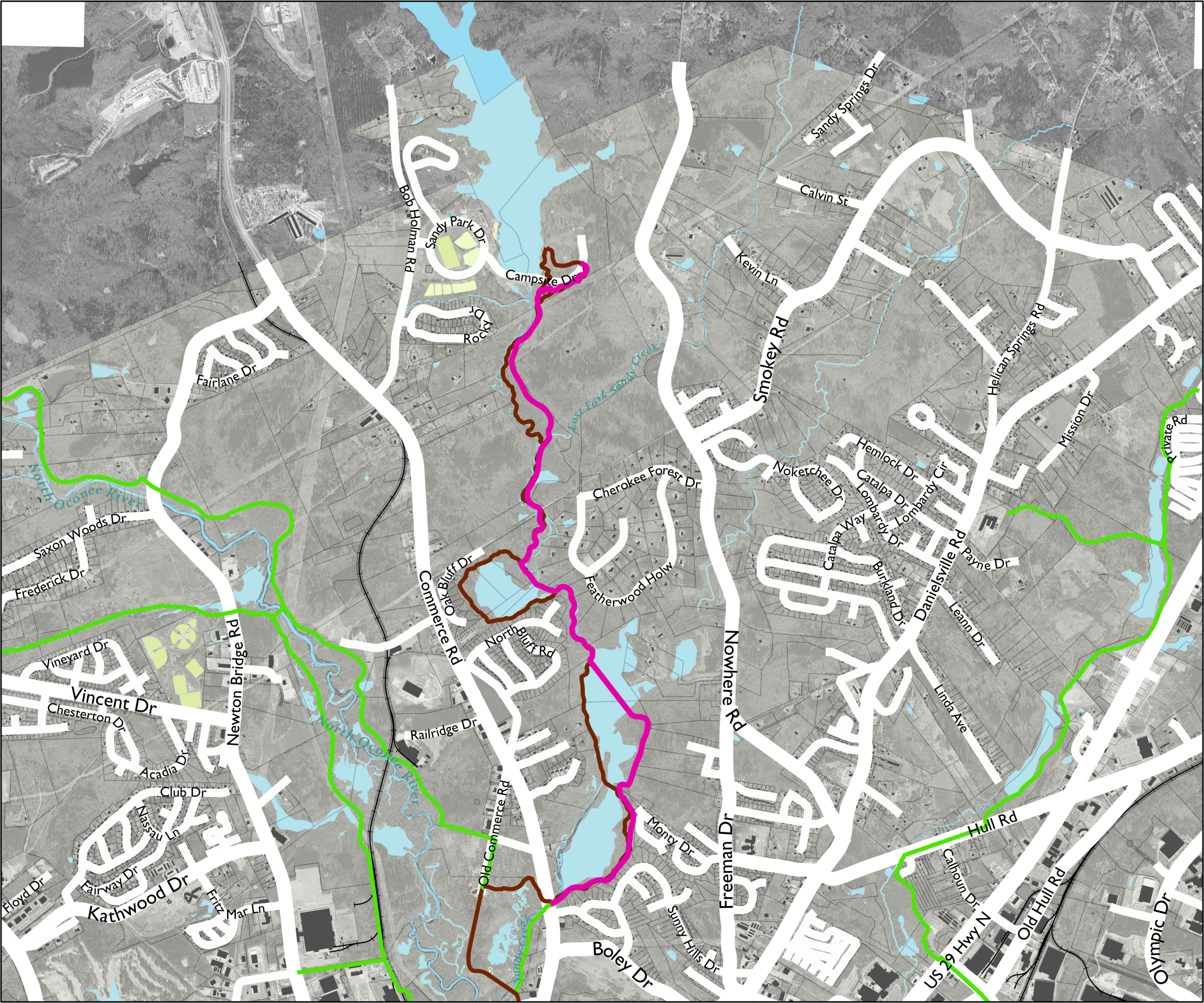

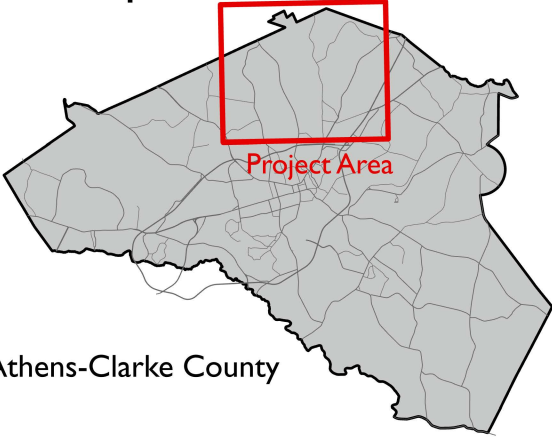

**Description:** This grant provides support for Phase I engineering services for the Cook's Trail redesign and restoration project.

### The following terms are agreed upon as conditions of this grant:

Riverview Foundation will provide written notice to the organization of any such breach of a material term, and an opportunity to cure of at least 30 days, prior to declaring any such breach.
- 6) The organization will send to the Foundation copies of any printed publicity regarding the awarding of the grant to the program supported by the grant; the organization may, if it chooses, refer to Riverview's support in any such publicity.
- 7) The following special condition will be observed: This grantee is a governmental entity and is considered to be a public charity under IRC Section 170(b)(1)(A)(v).
