The motion passed by unanimous vote.</p> <p>A motion was made by Council Member Coile, seconded by Council Member Kilpatrick, to approve a request from The Princeton Corporation for a quit claim deed for a portion of State Route 15 which was abandoned August 13, 1951. The motion passed by unanimous vote.</p> <p>Mayor Chambers presented the following State of the City Message.</p> <p>It is with a sense of nostalgia that we move from the City of Athens' government, as we have known it, into a new decade with a new form of government.</p> <p>The City of Athens has endured for 184 years, through two centuries. We pass on a legacy of financial stability, quality facilities, and a well-qualified, professional workforce to the new, unified government of Athens-Clarke County.</p> <p>Many years from now, we will look back on this new form of government, approved in 1990 by the citizens of Athens and Clarke County, with the same sense of tradition and history. I am proud to be a part of history in the making as Athens-Clarke County, on January 14th, becomes the second consolidated government in the State of Georgia and the twenty-eighth in the nation.</p> <p>I would like to thank the many elected officials who have served the City of Athens wisely and prudently. The service of our many county commissioners has been of equal value to our community. Without the cooperation the City of Athens has received through the years from the Clarke County Commission, we could not have achieved all we have for our community.</p> <p>A successful government could not have been achieved without the excellent public employees we have had through the years. Even with the excellent policy making and planning, nothing takes the place of the effective delivery of services by employees. We owe our appreciation to our loyal and efficient city employees.</p> <p>Our new form of government will call for many adjustments, and the immediate future of our employees may be stressful as changes can sometimes be. I would ask for their patience in looking at our new government as a challenge and opportunity to meet their career objectives.</p> <p>Accomplishments of the past year have been numerous. We are well on our way to completion of the new, downtown parking garage, which includes office space on the ground-level.</p> <p>The Middle Oconee Water Pollution Control Plant expansion, which will increase plant capacity from four to six million gallons per day, is under construction, with the first phase already in operation.</p> <p>We are continuing to work toward a regional water reservoir. A report which projects future water needs and evaluates reservoir sites should be complete within three months.</p> <p>Athens was recognized as the number one recycling city in Georgia by the Georgia Department of Human Resources. Our recycling program continues to be more effective. With the addition of a tub grinder, we are able to recycle Christmas trees and general yard waste.</p> <p>Fleet Management initiated a preventive maintenance program, which has cut emergency road calls by 85%.</p> <p>The Historic Preservation Commission continues to look at protecting our architectural resources to maintain our quality of life. The City has continued to be committed to preserving city-owned historic properties. A great deal of restoration work was completed in the Council Chamber of City Hall and in other areas of the building.</p> <p>The City has continued to work with the Athens-Clarke County Clean and Beautiful Commission as well as the Athens Tree Commission in protecting and enhancing the environmental balance and appearance of our community.</p> <p>Grand Slam 1990 was a very successful summer recreation program, which provided our youth with a place to spend their weekend evenings in well-directed, beneficial activities. As a result, the youth violence was reduced this summer by 65%.</p>
