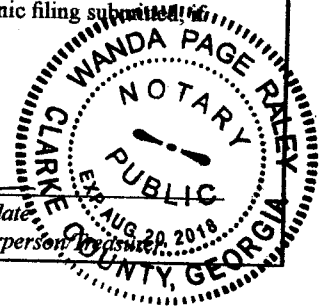

In addition to returning \$6,000 in contributions to five individuals as listed in the Itemized Expenses section above (4 x \$250 each, plus \$1,000), I also returned individual contributions each totaling \$100 or less to eleven (11) individuals. The total amount so returned was \$950.
