Project History



November 2017 – The citizens of Athens-Clarke County approved the TSPLOST 2018 Program Referendum which included project # 5 – Oconee Rivers Greenway Project.

December 2017 - The Oconee Rivers Greenway Commission recommended the Oak/Oconee Street Connector as a priority for TSPLOST implementation.

March 2018 – Athens-Clarke County Mayor and Commission approved the project concept.

July 2018 – GDOT approved the Bridge Replacement concept that incorporated the Greenway underpass.





Underpass requires GDOT lengthening the bridge during replacement project

Discussions are ongoing regarding construction of Trail Creek bridge foundations as part of GDOT project (ACCGov's expense)

ACCGov pursuing potential coordination for trail and bridge construction with GDOT contractor

May 2020 – Mayor and Commission consideration

Fall 2020/Winter 2021 - GDOT final design

Summer 2021 – GDOT letting project/construction start

Winter 2024 – Construction completion
