Abbreviated - Project Description: This project provides funding for a parking lot and multi-use trail from Nowhere Road to Sandy Creek Nature Center, at the end of Campsite Drive.

Project Location/Address: 1075 Nowhere Rd.

Site Specific Information: Proposed project would be located near an existing driveway on Property from Nowhere Rd., site Parcel number 143 007.

Project/Program Description: Multi-Use trail with parking connecting Athens Clarke County Property located at 1075 Nowhere Road to existing Sandy Creek Park (SCP) trail system. This project will expand access to SCP for Clarke County residents living to the east of the park. The proposed project will pave a 20-car paved parking lot near an existing driveway to the property and build. A paved cement Multi-Use trail for bicycles and pedestrians will provide access to SCP, beginning at the parking lot and terminating at the end of Campsite drive (approximately $\frac{1}{2}$ mile long). The Sandy Creek Park admission fee would be collectable via mobile app at this location.

Project Mission Statement/Selection Criteria: The mission of the proposed project aims to provide additional access to recreational opportunities to the North Athens Community. Currently, no county parks exist on the north side of Athens outside of Loop 10, except Sandy Creek Park and Holland Youth Sports Complex Park. Despite Sandy Creek Park being a relatively short walking or driving distance from many residents on the east side of the park (as close as 300 feet), entering the park currently requires a 14-20 minute drive Via the Loop 10. In keeping with the Triple Bottom line goals of the TSPLOST program for Social Well Being, the proposed project clearly improves equitable access to public facilities and infrastructure for the North Athens community. Additionally, the proposed project meets the following Program Goals: 1) Protects the community's existing Transportation Infrastructure Investments, 2) Reduces Pavement Maintenance deficit, 3) Reduces vehicle miles traveled and traffic congestion, 4) Reduces time spent traveling in vehicles, 5) Promotes increased

PROJECT JUSTIFICATION

How will the Project meet one or more of the Selection Criteria?

Promotes the Goal of improving Equitability of capital improvements throughout the Community:

The North Athens Community east of Nowhere Rd. has no access to recreational parks, despite many residents being within walking distance to the boundary of the County's largest recreational area, Sandy Creek Park. This project would allow easy access to the park via a Multi-Use trail and parking area and provide the North Athens Community at least one recreational area close to their homes (see attached letters of support).

Protects the community's existing Transportation Infrastructure Investments: This project would greatly reduce vehicle travel time by residents on the north side of Athens who wish to utilize Sandy Creek Park, and thus reduce use of infrastructure, by changing a 14-20min drive via the Loop10 to a 1-5min drive to the Multi-Use trailhead and parking lot off Nowhere Rd. (see attached Google Map).

Reduces Pavement Maintenance deficit: By reducing vehicle travel time and distance by residents who wish to utilize Sandy Creek Park east of Nowhere Rd., we could reduce the use of roadways such as Loop 10 and Hwy 441, thereby reducing maintenance.

Promotes increased access to existing public facilities: The North Athens Community east of Nowhere Rd. currently have no nearby recreational areas. This project would provide residents access to the existing facilities of Sandy Creek Park, by building a second point of entry on the east side of the park (see attached letters of support).

Reduces vehicle miles traveled and traffic congestion: This project would greatly reduce vehicle travel time for residents on the north side of Athens who wish to utilize Sandy Creek Park by changing a 15-20min drive via the Loop 10 to a 1-5min drive to the Multi-Use trailhead entering the Park. Moreover, the proposed project could reduce traffic congestion at the main park entrance on Hwy 441 by providing a secondary access point where bicycles and pedestrians could access the park off Nowhere Rd.

Reduces time spent traveling in vehicles: This project would greatly reduce vehicle travel by residents on the north side of Athens who wish to utilize Sandy Creek Park, by changing a 15-20min drive via the Loop 10 to a 1-5min drive to the Multi-Use trailhead. Moreover, a Multi-Use trail entrance would encourage the walking or biking into the Park instead of driving through the park in a vehicle.

Promotes Health and Safety: The proposed project provides access to the walking and hiking trails of Sandy Creek Park, which would provide ample exercise opportunities for the North Athens Community to east of Sandy Creek Park, where none currently exist. At present many residents walk or run along roadways without shoulders (especially along Smokey Rd.), many of which have speed limits of 50+MPH and thus present major health risk or death from vehicle accidents (see attached letters of support). Easy access to the large expanse of trails would not only protect residents who currently run and walk dangerous roadways, but also encourage residents to exercise who don't feel safe doing so currently. Exercise from walking, running, and bikes could greatly increase the health of residents in the North Athens Community.

Continues Sidewalk & Multi-Use Trail construction: The proposed plan would build approximately $\frac{1}{2}$ mile of Multi-Use trail in an area of Athens where none currently exist.

Triple Bottom Line Impacts

Positive Benefits for the Economic Prosperity of Athens-Clarke County: This project would add to the appeal of Real Estate in North Athens on and to the east of Nowhere Rd., which could lead to increased building of homes in the area, as well as, increased property value leading in increased property tax revenue.

Detrimental Impacts to the Economic Prosperity of Athens-Clarke County: No negative impacts on economic prosperity are predicted to occur because of the proposed project.

Positive Benefits for the Social Well-Being of our Residents and visitors: Providing parking and a Multi-Use Trail on the property would allow both residents and visitors not only a second access point to Sandy Creek Park but promote bicycling and hiking within the park. Providing residents with additional recreational activities in the county, especially where none currently exist, would directly benefit the social well-being of residents and visitors. The proposed project would also provide equitable access to recreational parks where none currently exist in North Athens east of Nowhere Rd., despite many residents in this area living within sight of the boundaries of the east side of Sandy Creek Park. Detrimental Impacts for the Social Well-Being of our Residents and visitors: No detrimental impacts for the social well-being of our residents and visitors are predicted to occur because of the proposed project.

Positive Impacts on the Environment: This project would provide the public access to natural spaces which will increase environmental awareness and as a result, its protection. Finally, reduced driving time for residents of North Athens to access Sandy Creek Park would reduce air pollution.

Detrimental Impacts on the Environment: There will be a small amount of negative environmental impacts from the construction of a paved driveway and parking lot, however these impacts will be minimal since no existing forest land or wetland are present on the proposed location of the parking lot. Moreover, a driveway and small parking area already exist at proposed location so it would not change the character of the landscape.

The property will be purchased to avoid a large ravine (which would require a costly bridge construction) between the parking lot on Nowhere Rd. and Campsite Drive in Sandy Creek Park. The construction cost of the Multi-Use Trail will be greatly reduced, reduce maintenance costs, and the trail will be easier to walk on by reducing elevation changes (hills to walk up and down).

If necessary to meet the Goals and Selection Criteria, describe what types of Bicycle access will be required.

Bicycle Access will be on the Multi-Use Trail. By putting a section of the trail across this property it will be much more accommodating to cyclists by reducing the elevation changes along the trail.

- *"Protect and Enhance the quality of natural areas that provide for recreation, clean water and habitat preservation."*






