Sewer Stub Size	Stub Charge

For multi-family construction, the sewer connection fee is the 3/4-inch sewer connection fee multiplied by the number of units, multiplied by a factor of 60%.

## Development

These fees are charged for review of new development plans and for water system and sewer system evaluations.

Development Permit Application Fee	\$130
Development Plan Review (per plan set, avg 5 pgs, no changes)	\$150
Water System Evaluation	\$50 per connection
Sewer System Evaluation	\$150 per connection
*** Water Main Inspection (per linear foot)	\$1.24
*** Sewer Line Inspection (per linear foot)	\$2.88

\*\*\* Minimum inspection fee is \$300 per contract.

## Other

**Paving Cut** \$700\*

**Bull Head Connection** \$100

\*Plus additional amounts, as determined by the Public Utilities Director, that reflect the cost of labor, equipment and other materials for the job (if required).

**Fire Hydrant Meter Rental** \$160

For water usage of 11,220 gallons. Water usage above 11,220 gallons will be charged per 1,000 gallons at the non-residential outdoor water use rate.

**DOT Right-of-Way Encroachment Permit** \$160
