

NOTICE OF PROPOSED POLLING LOCATION CHANGES

Pursuant to O.C.G.A. §§ 21-2-226, 262 & 265, the Athens-Clarke County Board of Elections and Voter Registration will make changes to its current polling locations beginning with the 2024 Presidential Preference Primary Election. Such proposed changes recommended by the Board of Elections and Voter Registration, consist of moving six Election Day polling locations for some voters, as well as adding one new polling place location, Miriam Moore Community Center, located at 410 McKinley Drive, Athens 30601. ACCGov residents' voting districts will not change as a part of the process, only the location at which some would vote in-person on Election Day.

Pursuant to O.C.G.A. § 21-2-226 and Ga. Comp. R. & Regs. r. 183-1-7-.01., upon the Board's approval, all voters affected by these changes will receive a new precinct card in the mail, 90 days prior to the 2024 Presidential Preference Primary Election.

The Board of Elections & Voter Registration will consider adoption of a final order related to implementing the proposed changes at its regular scheduled meeting on Tuesday, September 12, 2023 at the Athens-Clarke County Planning Auditorium located at 120 W Dougherty Street in Athens, at 4:30pm. Any person objecting thereto must file his or her objections with the Board of Elections and Voter Registration prior to Tuesday, September 12, 2023.

The proposed changes consist of:

Voters of 1A, who are currently assigned to Winterville Train Depot, beginning with the 2024 Presidential Preference Primary Election, will vote at Winterville Community Center, located at 371 N Church Street, Winterville 30683.

Voters of 4A, who are currently assigned to ACCGov Multimodal Transportation Center, beginning with the 2024 Presidential will vote at Athens-Ben Epps Airport Community Room, located at 1010 Ben Epps Drive, Athens 30606.

Voters of 5D, who are currently assigned to ACCGov Fleet Management Office, beginning with the 2024 Presidential Preference Primary Election, will vote at the Girl Scouts of Historic Georgia, located at 185 Newton Bridge Road, Athens 30607.

Voters of 6B, who are currently assigned to the Georgia Square Mall, beginning with the 2024 Presidential Preference Primary Election, will vote at the ACC Cooperative Extension Office, located at 275 Cleveland Road, Bogart 30622.

Voters of 6D, who are currently assigned to the Fire Station #4, beginning with the 2024 Presidential Preference Primary Election, will merge the precinct with the existing 5A located at Oglethorpe Avenue

Elementary School, 1150 Oglethorpe Avenue, Athens 30606 the ACC Cooperative Extension Office, located at 275 Cleveland Road, Athens 30606.

Voters of 7C, who are currently assigned to the Fire Station #3, beginning with the 2024 Presidential Preference Primary Election, will vote at the Milledge Avenue Baptist Church, located at 14690 S Milledge Avenue, Athens 30605.
