

## **Summary of Strategic Plan to Reduce & Prevent Homelessness (SPRPH) Public Comment Period**

The purpose of this document is to share a summary of the comprehensive public input campaign for the Strategic Plan to Reduce and Prevent Homelessness (SPRPH) between September 5 and September 27, 2023. Specifically, this document includes an overview of activities offered to the public, a thematic summary of comments received, and ACCGov's staff's response to these comments. This document was also shared with M&C as part of the Agenda Report associated with the scheduled vote on October 3, 2023. ### **Summary of Activities**

As outlined on pages 8-9 of the SPRPH, ACC stakeholders and residents were engaged in the development phase of the SPRPH between December 2022 -July 2023 through activities like:

1. 20 interviews with people currently or at risk of homelessness
2. 27 interviews with local service providers
3. ACCGov staff and stakeholders, including non-profit and for-profit housing developers, non-profit agencies, and business leaders
4. 3 targeted surveys (business community, students, and service providers) that garnered 327 unique responses
5. 8 listening sessions, attended by 30 stakeholders
6. HOME-ARP Allocation Plan activities (surveys, meetings, interviews, etc.)
7. Collaboration with the Athens Homeless Coalition to develop and disseminate a survey specifically for landlords; 19 responses were received between May 3-July 26, 2023
8. The accgov.com/arpa website was regularly updated with copies of presentations delivered during advisory committee meetings, summaries of proposed strategies, and details of engagement activities outlined above.

Between September 5 and September 27, 2023, residents were also asked to provide input on the final draft of the SPRPH before the Mayor and Commission's vote on October 3, 2023:

1. The accgov.com/arpa website was updated to include:
  - Full draft of plan, as well as a one-sheeter outlining key strategies in English and Spanish
  - Video recording of staff presenting an overview of the key components of the plan
  - Recording from August 16, 2023 ARPA Homelessness Advisory Committee meeting
  - Description and schedule of all public input opportunities related to this plan
2. Four in-person community forums whereby staff presented an overview of key plan components and accepted oral and written public comment. These events were held at locations and times accessible to stakeholders *and* residents who are most impacted by housing affordability:
  - Forum #1: Heard Park Multipurpose Room, Tuesday, September 5, 2023 (11 am -1 pm)
  - Forum #2: Snipes Water Resource Center, Wednesday, September 13, 2023 (3-5 pm)
  - Forum #3: ACC Library, Wednesday, September 20, 2023 (11am -1 pm)
  - Forum #4: ACC Library, Wednesday, September 20, 2023 (6-8 pm)

3. Online input form for individuals to provide written, confidential comment (September 5-27, 2023).

These activities were promoted heavily by staff through ACCGov News Flash, emails to stakeholders and non-profits (including Neighborhood Leaders), social media posts, flyers and A-frame posters in College Square, and interviews with local outlets.

Additionally, the public is invited to provide additional input and comments to the Mayor and Commission in relation to the SPRPH at the rescheduled M&C Regular Voting Session (Oct. 3, 2023). #### **Public Comment Received**

Over the public comment period (September 5 – September 27, 2023), ACCGov staff received a total of 915 comments and questions as outlined below. Residents were encouraged to participate in as many of the activities as possible, so it is difficult to discern a unique number of residents who participated in these activities (e.g., a resident may have submitted comment via the online form, attended a forum and sent an email to staff). Please note that the analysis below does not include comments or questions emailed directly to Mayor and Commission.



### ***Frequently Asked Questions (FAQs) Received by Staff:***

#### **1. How is ACCGov going to address root causes of homelessness, including:**

##### **a. Mental illness & substance abuse**

Mayor and Commission allocated ARPA funding into five “buckets,” or focal areas, on March 1, 2022. This allocation included \$4 million for behavioral health. That funding has been committed to provide additional financing for SPLOST 2020 Project 28, Mental Health Recovery Facility, following a recommendation from the Safety and Justice Committee, and then a Mayor and Commission vote on June 6, 2023. Additionally, several of the strategies in the SPRPH will assist individuals in connecting with services, including mental health and substance abuse treatment. For example, Strategy 4, Comprehensive Street Outreach (pg. 32) will enhance street outreach workers’ ability to form relationships with and provide support to unsheltered individuals. Those employees will provide case management and check-ins needed to ensure that clients are able to access (and continue accessing) needed care. Likewise, implementation of Strategy 3, Coordinated Entry

Improvement (pg. 26), will assist providers in assessing each individual's needs and referring them to the appropriate services.

**b. Lack of income**

Many commenters pointed out that there is a population of working homeless who, despite maintaining employment, do not receive adequate income to meet their needs. Many other homeless individuals face barriers to employment including high childcare costs, lack of transportation, inability to obtain a job due to lack of a permanent address or bank account, criminal record, and other varied issues. The SPRPH addresses these needs directly through Strategy 10, Partnerships for Employment (pg. 52). This strategy will facilitate coordination between service providers and employment partners. The business survey completed during SPRPH development (see Appendix D, p. 71) indicated that there was significant interest from local businesses in playing a role in supporting successful employment and transition of homeless individuals. If implemented, this strategy will work to facilitate the connections and support needed to assist homeless individuals in obtaining and maintaining employment. This strategy may also assist homeless individuals in accessing the training needed to enhance employment prospects and obtain a higher paying job.

A second strategy which may be instrumental assisting individuals at risk of homelessness in maintaining or obtaining employment is Strategy 7, Diversion and Rapid Exit (pg. 41). This strategy will pair intensive case management with limited flexible funding, which could come from Strategy 8 (Support Fund to Reduce & Prevent Homelessness, p. 46). For example, this funding could be used to assist an individual who is already employed with a car repair, ensuring that the individual does not lose their job. Alternately, funding could be used to assist with employment start-up costs such as uniforms or equipment, allowing an individual to obtain employment.

Mayor and Commission has allocated an additional \$4 million of ARPA funding to [Business Development and Workforce Support](#). This allocation is meant to connect Athens residents with high wage employment. A Business Development and Workforce Support Task Force has been convened and will be meeting from August to December 2023 to define achievable outcomes and programming recommendations for this bucket area.

**c. Lack of affordable housing**

Given the inherent inter-relatedness between affordable housing and homelessness, strategic plans were developed concurrently by HR&A Advisors and The Cloudburst Groups, respectively, in collaboration with the ACCGov Housing and Community Development Department and interdepartmental ARPA team, and in consultation with local stakeholders and community members. If accepted on October 3, 2023, the [Affordable Housing Investment Strategy](#) will guide ACCGov in obtaining and dedicating additional funding to affordable housing projects.

To date, ACCGov has allocated ~\$15 million in ARPA funding to affordable housing projects including new affordable home construction, home renovation for low-income homeowners,

and the North Downtown Athens Redevelopment project. More information about these projects is available on the [ARPA Affordable Housing](#) web page.

Additionally, the SPRPH seeks to eliminate some of the barriers unhoused individuals face in accessing affordable housing directly through Strategy 9, Landlord-Focused Strategies (pg. 47). Many homeless individuals who obtain rapid rehousing vouchers or Section 8 vouchers are unable to find housing due to a lack of properties accepting these vouchers locally. While many commenters noted that “it is not in a property manager’s business interest to accept a “risky” tenant such as a homeless person,” this strategy will address those concerns by providing initiatives and risk mitigation measures paired with ongoing support of the tenant to promote a successful transition. The goal of this strategy is to increase the number of units available and willing to individuals transitioning out of homelessness.

**2. How will programs be sustained after ARPA funding is depleted?**

While some of the funding in this plan is one-time in nature (for example, the bulk of the \$2.2 million to build or rehabilitate additional low-barrier shelter units), there will be ongoing costs associated with most of the strategies. One of the goals of this plan is to strengthen the CoC’s competitiveness for federal funding and capacity to apply for other sources of funding, as outlined in Goal 1, Strengthen CoC Capacity (pg. 23). This will be accomplished through hiring a dedicated staff person to spearhead these efforts, as well as through improved data collection, which will better demonstrate ACC’s need for federal funding. ACC’s Mayor and Commission may also choose to consider other local methods to provide ongoing funding.

**3. Why is Athens a hub for homeless services? It seems that adding more services will continue to enforce ACC’s reputation as a “Hub” and lead to more homeless individuals coming here. ACC taxpayers should not be expected to pay for services for individuals migrating in from other areas. How do we get neighboring counties to pull their weight?**

Athens-Clarke County is a regional hub for a lot of different services and offerings, including education, healthcare, culture & arts, and social services. According to Table 5 in the SPRPH (pg. 38 and included below), ACC has the greatest number of year-round shelter and transitional housing beds in the region. Of all surrounding counties, only Barrow County has 25 transitional housing beds.

While Athens may offer more homeless services than surrounding counties, the [2023 Point-in-Time Count](#) (PIT) identified that the most common reason why homeless individuals came to ACC was because of “Family/Friends” (the second most common reason was “I previously lived in ACC”, and the third was “Better Resources/Services”). The 2023 PIT count also identified that 79% of homeless individuals surveyed have lived in Athens for at least 1 year and that the last county of permanent residence for the majority of respondents was Athens-Clarke. In short, while individuals may be coming to ACC specifically seeking shelter or homeless services, the vast majority of individuals experiencing homelessness are county residents.

Goal #1 of the SPRPH seeks to Strengthen CoC Capacity. In doing so, the Athens Homeless Coalition (currently the governing body of the Athens-Clarke County CoC) would have increased capacity to establish new and grow existing relationships with service providers across county lines. The Athens Homeless Coalition has expressed a strong desire to help those organizations (e.g., share best practices) to increase their capacity to better address homelessness in neighboring counties. The Mayor & Commission have also expressed a desire in opening lines of communication with surrounding local governments about this issue. Finally, residents may also express their concerns about this issue with elected officials at the state level.

**4. What are the outcomes of the \$2.5 million in funding to the First Step sanctioned homeless encampment? What is the encampment’s status and what will happen over the coming months?**

The First Step encampment has been in operation since March 2022 and has served 311 individuals in that time (numbers provided through August 2023 reporting period). As with other ACCGov ARPA contracts, the operator submits monthly reports detailing expenditures and performance outcomes. The sanctioned homeless encampment contract is set to expire on December 31, 2023. Mayor and Commission will be voting on October 3, 2023 on a transition plan, including hotel vouchers for current residents during the colder months (January-April 2024). The full transition plan is available as Attachment 1 on the [Agenda Item](#).

**5. What is the housing first model? Has it been shown to work?**

As defined by the [National Alliance to End Homelessness](#), “Housing First is a homeless assistance approach that prioritizes providing permanent housing to people experiencing homelessness, thus ending their homelessness and serving as a platform from which they can pursue personal goals and improve their quality of life. This approach is guided by the belief that people need basic necessities like food and a place to live before attending to anything less critical, such as getting a job, budgeting properly, or attending to substance use issues.” A brief overview of the history and evidence base around the housing first model is available from HUD here:

**6. If this plan is implemented how will success be measured? What data will we use to determine which strategies are working?**

There are a variety of ways to measure the success of the plan. For example, the total number of homeless individuals in ACC is an obvious metric that comes to mind for many. This is measured through annual Point in Time counts and through the use of HMIS (Homeless Management Information System) data. However, the total homeless population can be heavily influenced by outside variables, including broader economic and nationwide trends in homelessness rates. Additionally, as Coordinated Entry practices improve, ACC expects to gain access to data from service providers who were not previously using HMIS or sharing by-name data with other providers. This improvement in data management could lead to the temporary appearance of an increase in homelessness, when in fact the rise is due to better data collection.

Thus, it is important to look at a variety of performance measures to determine the success of the plan. Each strategy of the SPRPH lists a few performance measures suggested by the Cloudburst Group, along with methods to track those measures. Monitoring the number of exits from homelessness, average length of time to exit homelessness, 6-months and 12-month outcomes following an exit from homelessness, and successful connection to services such as mental health care, are just a few of the methods ACC can use to measure the success of the plan. If numbers are not trending in the right direction (for example, if the average time to exit homelessness is increasing rather than decreasing) ACCGov will work to identify potential causes and will work with contracted service providers to adjust their programs to address any issues. Please see pages 61-63 of the SPRPH for a summary of proposed tracking and reporting of activities related to the strategies outlined within.

**7. How many positions are funded through this plan? How does paying people to deal with homelessness help prevent homelessness?**

If the SPRPH is accepted by the M&C, then ACCGov's Housing and Community Development Department (HCD) will release a series of Requests for Proposals (RFP) to solicit organizations interested in providing the programs outlined in the 10 strategies (related strategies will be grouped together, rather than releasing 10 separate RFPs). Each organization submitting a proposal sets their own budget, including any new employees required to successfully implement their proposed program. Depending on existing capacity and employee roles within the organization, this could be a full-time staff request, part-time staff request, or an organization may choose to use existing staff and request funding for other elements of the program. HCD will evaluate and recommend organizations to receive funding based on overall capacity and feasibility, agency risk, and value of the services provided. Mayor & Commission would then vote on the recommended providers and decide final awards. Due to this competitive RFP process, the exact number of positions funded through this plan is not known at this time. However, a full-time position is anticipated for Strategy 1, and full or part time positions are anticipated for other strategies. Anticipated components of funding are listed on pages 58-60.

Generally, service providers need experienced and qualified staff to implement their programs designed to prevent and/or reduce homelessness. It is case managers, for example, who meet with individuals experiencing homelessness (or at risk of) on a regular basis to identify ways in which they

can exit the system. For example, staff involved in Strategy 7, Implement Diversion and Rapid Exit (pg. 41) would offer intensive case management over a short time duration to assist households at risk of homelessness in identifying alternative solutions and accessing funding to address temporary or one-time needs. Similarly, staff working to implement Strategy 8, Flexible Housing Fund and Strategy 9, Landlord-Focused Initiatives could help *reduce* homelessness by assisting individuals currently experiencing homelessness directly with housing-focused strategies

**8. How does this plan help address the needs of homeless families and students? What about other specialized populations (e.g., survivors of domestic violence, LGBTQIA+, etc.)?**

None of these strategies specifically exclude the needs of families, students or other specialized populations that are experiencing or are at risk of experiencing homelessness. In implementing any strategy outlined in this plan, ACCGov staff will work closely with service providers selected through a competitive RFP process to ensure that the specific needs of specialized populations are considered.

**Full Public Comments**

The following table includes comments received from staff during the activities outlined above. They do not include comments emailed directly to Mayor and Commission. Comments submitted through the online survey or email appear here verbatim. Staff made every effort possible to capture comments shared during in-person meetings (e.g., agenda setting and public forums) as close to verbatim as possible.

To a regional approach, there's nothing more frustrating than to see people who are here who don't know what they are doing here. It's frustrating to see people wind up here. Our first act is to talk to them about getting them to the places they came from. If the counties around us are not helping, that's why we need a person who is set in the Coalition, who can create these conversations with Jackson, Barrow etc. They don't know how to apply for the federal funds, we can help empower them. We need

			a staff person for that. We need regional solutions. If they refuse, we will think to get other communities to do their part. It's a free country so they can come here. I oversee hotel voucher program and permanent housing vouchers as well as fixed income disability. They only get \$900 per month. That is nothing. It can't pay for market rate units. They can't get housing so they stay in the hotel. That means other people can't have a place at the hotel. We are doing everything they can do, my best efforts, and we still can't find housing in Athens. How do we build more housing? I talked to a couple of developers and we spent 2 years to go through ordinances and zoning. We tried to create a treatment house to help people build those new neural pathways to rejoin the community. It's been taking years. We are still trying to push forward to move dirt. We need that facility, we need a case worker to find people a place to sleep. Them and I put together can't find housing for people. We want a better data management system like HMIS for all providers. We need to integrate housing, hospital and jail related data.
Forum	1		For me being homeless right now, I am working at the salvation army right now. For me being behind the curtain, there is difficulty finding work (you need someone to watch your children while you work, etc.) & the stress can affect your mental situation. Some people who do want a job do not get one just because of the way they look, that also causes problems for them mentally. The outreach would be more beneficial because a lot of people come here to hang out, but they need some more people out there. Not one organization or one person cannot do it all. The salvation army has helped me. The funding that is a big issue too, as you are pouring out and helping out other people you need help too

I came home one night and saw a man lying on the ground. it made me freeze. It was 22 degrees outside, so I immediately stopped my car and called the police. the police and ambulance showed up and they were able to arouse him and I was able to start breathing again. The EMT stood in front of him and he was so disoriented he could not tell his name for a bit. He said how many fingers he was holding up, and the man answered. The police went back in the car, but said there was nothing they could do. They left the man in the freezing temperatures because there was nothing else that they could do. You mentioned that the 1:1 takes money, sometimes we will volunteer and please do the 1:1s.
Forum	3		Or we need to put the money in putting people inside and not keeping them outside. As a stakeholder who has sat through all of these sessions but this is very frustrating and this is the last time I am wasting my time.

There can be Medicaid, and also for the alcoholics or the drug users - they need to be off or in rehab the whole time. There has to be some kind of (restrictions)... That's the working homeless issue. The CCSD gets voucher money to deal with homelessness. They get housed in couched in trailers. We can't make it about one thing. The working homeless who lost vouchers. Then the other people who are mentally ill need mental health treatment housing. State needs to take ownership.
Forum	4		Case management is needed. Our COC is needed because it's a struggle with providing services. The housing vouchers are a momentum starter. A good percentage of them are prepared to go housing. The landlords want and should come to the table.

Email	general		I wonder why 911 calls to police about homelessness increased so much in 2022 from all the prior years (despite the undercount in 2021.) Also note that, of 2023 calls about the homeless, only 5% involved violence.
Email	general		The coalition nonprofit stuff seems much like discussed.
M&C Agenda Setting	general		Athens resident who has been working with Advantage Street Outreach team is concerned about Athens cutting themselves off from our unhoused community members he's been involved in discussions regarding this strategic plan and has heard comments about Athens being a hub, and if it were to pass these plans it would become more of a hub. There is a sadness he feels when he hears these comments because it feels like people are saying "we don't want these people here at all" because these plans do actually address the challenges of housing and homelessness on a local, regional and state level by empowering the homeless coalition to build coalition and take more macro level action on a regional and state level. This might be a news flash but we actually send our people elsewhere as well. All the time we're sending people to Macon, Augusta, and Monroe because we don't have housing here where we can house people at a fair market value. There is such a premium and such a limit, we are sending people elsewhere as well people who have lived in Athens their whole lives. So, I think we need both of these plans to be able to take care of our community members that are living here now and that have been here and I think there are creative ways that we can fund the affordable housing plan that could even also include a small property tax rollback for average residents. So overall I just want to say let's not close ourselves off to our community members because these folks may have a lot to offer us as well so let's stay open to the things we have to offer each other.

M&C Agenda Setting	general	Although I know this is the agenda setting session and not the voting session. I hope that these plans are approved during the next voting meeting in October. These are very important plans that are very comprehensive, very data driven, they offer from all the data used the best possible recommendations that the team were able to produce that address these issues in terms of affordable housing as well as homelessness. I hope that since not doing anything is not an option, we need to put our resources even if it does mean actually putting money toward these issues as soon as we can towards these investments in local housing and preventing homelessness and being able to vote on that in the next voting meeting in October so that the associated advisory committees can begin to draft plans to set these in motion. I also hope that if these plans are adopted that before the voting meeting all of the commissioners can make sure to do a very deep dive into these plans and that if they do have issues with one aspect or the other of the plan that they are able to specifically bring up issues with certain options and portions of the plan and can be discussed in terms of the plans adoption versus the alternative being a road to denial and not accepting the plan because something needs to be done and some amount of resources need to be given towards these plans that I hope are approved in October's meeting.
M&C Agenda Setting	general	I am speaking towards affordable housing, homelessness, and homelessness and I want to use a term "unintended consequences". I'm going to take a page from Commissioner Houle's playbook and talk about let's pretend for a second that the bathtub has running water and it's running until it overflows. You grab a mop and start cleaning up the water as it continues to rise and flow over the tub. You call your family in to bring more mops and they diligently mop up water right beside you. Water begins to flow downstairs and you begin to call your neighbors with their mops. They are compassionate souls and they begin to come over to help you, it's their civic duty. The water then begins to flow over onto the streets, and you call your city officials because they were elected to help. The city officials call a special meeting to discuss and vote on what should be done after a 3-hour session. The city officials vote for a special study on the dangers of overflowing bathtubs and to get insight on what other similar towns are doing about similar water situations. Admitting that they are ill equipped to determine how to tackle the ongoing citywide problem, the county officials call for a resolution to announce their concern for the rising problem to mitigate the flooding resolution. Whereas we have flooding problems in one house, we ask the community to turn on the water in their bathtubs so we can level out the water and now flood into the streets to establish an equitable water level, and to establish equitable living conditions for all residents.

		Whereas compassion dictates we keep people out of the water. The city council will assemble a study to purchase boats and ask for a submission of RFPs to vote on purchasing boats for everyone in the community. Whereas this is a humane and equitable effort to keep people dry we will also consider electric boats to support our green eco-friendly mandate. In the meantime, the city council cannot come to an agreement on the size of the boat and whether rowboats would be considered offensive to some parties a commission on diversity, equity and inclusion is discussed in order to maintain standards of diversity there is a motion on the board to check with Portland or Seattle to see if they have statistics on rowboats versus electric boats in times of crisis, meanwhile there is little concern about the water that is still overflowing the bathtub that started it all in the first place. This is episode one of let's pretend for a second.
M&C Agenda Setting	general	Episode 2: Let's pretend that the water is still flowing because of a faucet that has not been shut off. Water continues to flow and has saturated the town an unsustainable crisis exists. Let's pretend that this impossible situation requires help from the federal government. A quote grant writing team is summoned from the local university to write a compelling grant for funds. As a request for the federal dollars is being drafted there is a motion called for a SPLOST referendum to add another 1% sales tax on every dollar spent in this city. How should those dollars be spent you ask? Residents are homeless because of the flooding, property values are depreciating businesses have closed their doors and moving to cities that are more secure. In order to engage the public a notice is added to the website calling for project proposals. Sales tax dollars will fund the projects as well-organized elite and already well funded groups present detailed proposals there is to be a project wish list complete with an itemized dollar amount for each amenity. Once all proposals for funds have been submitted the city council will vote on the best and brightest smart town elite ideas and budget them for next year's budget. The project list is approved. Important note: the project list that details the culprit of the water leak is rejected. All the while the water continues to run from the same bathtub that started this story. Meanwhile the town remains underwater literally and financially. What's to be done? The city council decides to hire a consultant firm at \$250k to do a study on the water overflow. The consultant recommends project clean water amongst a multimillion-dollar water purifying system that will purify the water still standing in the streams. It is promoted as a health and safety project that can double a leisure service youth project to provide clean swimming water with a bang for your buck. While the multimillion-dollar facility is being discussed month after month the council makes a motion on an act to stem the tide. A mandate to conserve water as well as a

			city-wide moratorium on bathtub usage because of the water shortage. A closed-door meeting is held by the city council to discuss what the public should not be told yet. Let's pretend for a second that it is insane to keep on doing the same thing again and again and the things aren't working. Stop bleeding the funds and get to the source
Forum	general		Seems like you are creating this money to create more money. How are we trying to get the number of homeless people down? This is a lot of administrative costs. All the money, I mean 2.2 million is being spent on just administrative costs. If you increase capacity with this money, you increasing the hub of services which makes the people to come here more. Cloudburst doesn't have a great record of solving homelessness. How will this be more different? Where has that been showed to help? What is a measure of success? 2.2 million was spent. but no success. what's the measure of failure and when to stop the money for being spent on this? These are my tax money and it is only getting worse.
Forum	general		I have been a ACC citizen since 1999, I have lived off of North Ave. for the last 19 years. and I have seen how the homelessness in that area has grown. And I have seen different degrees of it - I have seen those with a drug problem and I have seen those who just need a little bit to get back right. I am a grad student who after a ten-year illness picked myself back up, I went back to school at the age 59 but after seeing what I am seeing in my neighborhood - I am originally from Memphis, TN but I ain't going back to TN. I have decided that I want to be a part of the solution. I did not come here to ask questions, but I came here to ask solutions because I want to be a part of the solution and bring all the sectors of the community together either by opening up doors or setting up a nonprofit. I do not want to see the redundancy of us taking time out of our schedule to hear the same thing every day. are we not asking the right questions? we have five things going on that is the part of the same problem. we need a team set up like the United Nations that is set up to help solve all the problems from different angles. but throwing money at the solution, specifically tax payer money, is not going to solve the problem. We cannot put a band aid on the problem - where I live I see it's getting worse by the day and by the minute. someone mentioned what is going on in CA and they mentioned the word accountability - it is one thing to have something to give but holding counties accountable - for those who drop off their people in Athens. the tax payers should be given constantly given updates and everyone who is a part of the team like the United Nations should be representative of everyone in this room. we need to create another strategic plan to address all the solutions and work through them. I brought this up with my professor last night and he said - "well this is what we are

			doing in Chicago," let us take a page out of the book of successful cities. I am telling you "put me into work," I am not going out like this.
Forum	general		I think it's about us. Drugs and crime go hand in hand. None of these looked at the cause. How are we spending 5 million on something that we don't even know about the cause? Forum	general		There are people living here with no homes. In the last 18 months, that are known drop-offs who are dropped off by agencies from hospitals.
Forum	general		I saw west Athens and Bethel. Affordable housing that is being paid with HOME, CDBG and ARPA funds and money. How many units are being built?
Forum	general		The reality is this will go to the commission and mayor. They will vote on it on Oct 3. This will be the last time they will get feedback.
Forum	general		Ok so, I want to address the questions that business owner had. There is no mention of MH or Substance abuse. Greater than 50% of people have Mental Health/Substance Abuse (MH/SA). I'm from California and let's take a look there. They spent 20 billion in the state and nothing to show for it. Now, they put 4 billion into MH services and centers. Now the care court process in California can make people get treatment. Even though its only 4 billion, it's all on MH. You could have developed Advantage but you didn't - they don't put this 7 million into Advantage. They can really help. This will help working homeless people. They will find the rent. You are putting the wrong people in rapid rehousing. You can make a huge dent right away with Advantage Behavioral.
Forum	general		What I want to say is, you don't want to give none of it back? Why can't we have the 55 people to build these. We have a neat staff. We have seen the places moving up and staff is better. We got a lot of people coming in with good attitudes. I just want to know why all this money... not going to those 55 people.
Forum	general		We aren't addressing the root of the problem. the service providers are thinking that they are helping but they really aren't.
Forum	general		You cannot do anything about homelessness unless you go to the "top," and you cannot do anything local without going to the "top." If you have never lived homeless you do not know what they need, taking money is an opportunity to steal money from those who need it.
Forum	general		I was in the woods for a few years working as street outreach. writing grants to create these programs but we need to come together as one to solve this problem. It's not about us it's about them. I will still work in any way I can but if I can get a bottle of water. We need to listen to the people. We need to unify together for solutions. Try to see where we can get together.
Forum	general		First of all, I strongly support many endeavors in ACC. What other communities have done the housing first model in the USA and have been successful? There is a reason I ask this, I have done my research and I have found more failures than I have found successes. I want to support but throwing money at something

			other communities have not been successful with is concerning. That's another thing, spending the 4.4 million dollars on this without a way to sustain it is concerning. If you take my comment as being totally negative you are misunderstanding. I went to the meeting yesterday and there were many questions that came up that there were few answers. I read the cloudburst report and there are many, many flaws in this report. You talk about wanting input, there was something before the M&C about a police advisory committee and 84% of the community said that they did not want one - and yet the M&C had one. I want you to be successful.
Forum	general		The question goes back - he asked and several people have asked - you get this money. and we ask: what about the next year, and the next year and you say we do not know. We already did this with the tent city and now poof - gone! This was an experimental program, what went on with them? That is my question: where are they going to go? Is there money coming from somewhere else to move them somewhere else? They were scattered around before, and the "tent city" brought them together to receive services and now that this program has ended that they are back to being scattered out.
Forum	general		One of these things, I keep coming to hear stuff differently. I know that you are just providing information to the mayor. All we get is a PowerPoint. What is the HMIS? Where is their data that shows that 1200 or 2000 people? How do you see this database? Where is it? I hear your story. I wonder if there's something I can do to contribute to this story. I don't have that equipment but I know people who do. 2000 or 6000, is it not public? What is the greatest need? This is what falling in the cracks looks like. It's not being done since 1991 since it's been unified. We keep making the mention of connection to services. That's a problem, low-barrier problem. Non-profits by nature compete with each other so they won't work together. That's very common sense. And many people who are homeless before and never want to remember that. People have experience and have lived experience. And how they got past it.
Forum	general		You are asking the tax payers of Clarke County to pay 4 million dollars, I do not see any staff increases etc. I go to the hospital, I cannot get in because of the homeless. I go to the mall, I cannot get in because of the homeless. I do not see this problem in Oconee or Jackson County, and now you are asking for more! Are we recruiting for more people to come?
Forum	general		My dad was commissioner for 26 yrs. Athens has changed so much from taking so many funds. They go everywhere but they don't really help. The money was mismanaged and it was supposed to clean up Athens. You can't go anywhere without feeling like you

			can't do something. We just want to do our 10%. We can't help the whole world. Why are we promoting people to come here?
Forum	general		I would like to point out that \$2 million is allocated for services. Only \$1 million for transition to permanent housing. Why do you think you won't increase the number of people who are homeless? Because right now, if we have a 73 percent turnover, it costs \$13k per year per person. How will you ensure the turnover rate to increase when you have more people coming in here and depleting our services? I have one more question, what is the budget for HCD?
Forum	general		If something like refugee drop-off happens, then it would deplete our resources. I was curious how you found cloudburst? What was the cost of their funding? Their total budget was \$133k. It was paid by ARPA? I know money has to be spent by 2026. Can it be used for other stuff? Because we have \$4 million left. Looking at the goals, the rapid-exit, is it to help with education, employment... has that been a goal in conjunction to encampment people. These goals are great but are they working?
Forum	general		My experience briefly, I didn't have a job. I was homeless 5 times. I'm a proud prodigy of provided programs. As a homeless person, it's up to you to do the work. Tension becomes hot when you talk about money around people who have none. You are a prodigy of programs and you have to do the work. Even if the tents have rain, we are trying to do the work. It's in our mind that we can't do this or do that. I started my career. If you are willing to do the work go stand up for something. If you ain't got it, then make it work for you. If they don't make you feel comfortable, then you got to do the work. Just because we throw the money don't mean the change will happen unless we are together. We are in this room caring about the same room. I still do the work. I still try. I'm speaking on behalf of the coalition and the homeless people.
Forum	general		We are against wasting money with our money.
Forum	general		What is working in our programs, and what's not? Where are the gaps in funding? When we talk about homelessness the experience intersects differently for everyone. We want to create that dialogue table. We don't have numbers and that is why we are trying to.
Forum	general		When I invest financially or time on something. I want to see ROI. I don't want to contribute anymore if I don't have ROI. We need to see data.
Forum	general		I want to attest to the fact for the rules and regulations that are involved for state, local, and federal that are not the way it was in the 1960s. It is not the way where we used to do business by handshake. I want to address Maslow's hierarchy of needs. If you are going to build a house: you must first look at the topography and get a design. But until you see a foundation laid that is visual - people out there working and putting up a structure - you say "this

		<p>is really going to happen." There is no visual happening in Athens and that is reducing the supportiveness you are going to accomplish. The hierarchy of needs does not start out with someone needing a home. It starts out with someone housing them - it could be a neighbor or a church. Nobody that is paying taxes or is paying for the things that they need..... there used to be starter homes, a one bedroom and a one bath. You have to start somewhere and the foundation is being built through PowerPoints but we are looking for the structure. I look to the lady at the salvation army - with the structure - having the land and having the space. You have to talk to a broad community and start giving visuals to get a broad support.</p>
Forum	general	<p>If you don't put any of these monies in place without the plan, then it's a waste. A circle. Spend your flex amount is what it's like.</p>
Forum	general	<p>Can we know where these properties will be located? Is there any list of properties? I have constructive criticism of the homeless and affordable housing plans. It's like healing gun shot with gauze. You have no self-worth, no motivation, and I want to see a reformation process. Not just a tent. It's counter intuitive. We need to fix the problem like psych evals and take their problems and provide solutions. Just because we staff the coalition, doesn't solve anything b/c it's a minuscule part of the problem. We apparently are going about it the wrong way. Fix the problem, the housing is just a bandage. We need REFORMATION and stability.</p>
Forum	general	<p>Thanks for the presentation. I like the COC. Working for Advantage, I have worked with case management and worked with the COC. Working with different people to make COC better. Been homeless and housing first model is great. I moved here from Atlanta. I was on the streets and doing very bad. I was hearing voices and everything. The work you're doing is very effective. Street outreach and everything coming together. I am on the coalition board and happened to have lived experience. Your minds can take you over. Separate you from the real world. It's rough, really rough, you have to get stable first and then you need a house and then case manager and you'll want to work after that. You don't want to get out of the bed, you don't want to go to the job because... you need a support system. I am working and you need all at the table. You need all forces and come up with a plan. I just</p>

			want to thank you and let you know that there's hope. I've got my BS, masters and working on doctoral.
Forum	general		As a service hub, we don't have any hospitals like Ridgewood or other stuff for addiction, substance abuse. How can we even consider ourselves a service hub when we don't have these resources to provide?
Forum	general		If you remodel a house, maybe it is an old house and if you remodel a house - and you picked out the colors and the flooring and a person who knows more about the house says you have to fix the roof first, and what I see with HCD there is a step-by-step process that is extremely frustrating and it has to be extremely frustrating to you guys, and I know people who renovated a house and put paper in the walls to live in there day after day. But when I hear, and I would love to hear and I need to know if the 6,000 thing that the fellow mentioned was accurate - the people of Athens need to know. If the people of Athens do not know, it will not be a pretty picture. There is an overflow thing and it does not make sense. We have an oversight committee, are they paid? Some of these groups, they are organized with boards and everything but are there things coming in everyday like this homeless flood - are there other groups or organizations that can yield some of their organized people to help with something like this? I feel like our resources are spread thin - can we not work together to fix this thing?

No one wants to live with people who live with this experience. She wouldn't take meds. I'd also like to ask the gentleman, what was the first step to getting out of it? The drug addiction, you can't help them unless they want to help themselves. When it comes to MH, it's not just a slight case of depression/anxiety. I don't see how you will get them to a place and get it all better.
Forum	general		Forty years ago, I ran a homeless program in Athens-Clarke County and I thought I could cure homelessness. I have seen dozens of these, have seen millions and maybe a billion but it may be like he said - a Band-Aid. But what I have come to think that it may sound naive but if people out there who are truly interested would adopt a homeless - maybe not into their homes, of course not into their homes but shepherd them with a class or through resources, I can see y'all helping develop such a program and I know it sounds naive and I think it can start a solution.

I want to go back to something that we started the meeting with "do not let perfect get in the way of progress," I - as a taxpayer think we need to do something. For folks who think that this is not it - I would love to know what your solutions were instead of attacking someone who is trying to do something in their community.
Forum	general		Why is it that homeless people are stereotyped as people who are prostitutes, drug users, mentally ill? You all don't know. Live homeless, then you will know. I don't look like I live in a tent. I also write poetry and wrote a book and change the food. Just because you live in tents, don't mean you are uneducated or second-class citizens.
Forum	general		My name is Katrina and I'm like most people in the encampments, they are simply falling on dark times. We are smart educated people. If you gave us a chance. One minute you are an educated scholar, next minute, you are going to implode. It doesn't make you a criminal. Ignorance is bliss. My beloved people, my family and friends, they are told dirty stupid things on the street. We need help sometimes. Not a handout. A chance to live with dignity.
Forum	general		330 people have gone through encampment and 73 percent of people are in permanent housing now. Some are case-by-case. Some leave early, some stay because it's hard to transition. We create a sense of community. We partner with Advantage. We provide them resources like medication, housing, & employment.
Forum	general		There's a concern in the community. A worry, that as you provide services, the numbers will grow. When I look at the homeless population, we will never reduce the number because the number is always increasing. We might be successful if the number doesn't grow. This is creating homelessness faster than ever. We will unfortunately be inviting even more people to ACC
Forum	general		18 people in this town may spend \$18,000, 18 homeless people will probably cost us the same amount. What we are doing in

			Athens is saying bring us your homeless, bring us your alcohol, bring us your drug addiction and have Piedmont Hospital take care of all of them.
Forum	general		For this money in year 2, do we have any guarantee of funding after year 2? Where are the funds to maintain the salaries and other stuff?
Forum	general		I have a compliment for you all. You have done a fabulous job of collecting solutions for a difficult problem. I hope the commission spends a lot of time thinking about it instead of giving a negative response of "we don't want those people here". You've been giving thoughtful solutions.
Forum	general		This seems to me like there's more drug overdoses.
Forum	general		Street gang and drugs, that's the problem. Every other day we have overdoses and deaths. The street gangs and drugs are messing this city up.
Forum	general		You just mentioned a MH facility with 66 beds. Can you tell us how many homelessness shelters there are and their beds? Barrow has less than 12 beds.
Forum	general		We are getting buried by so many people who represent the same entities. For example, I get contacted from multiple police support orgs asking for money. When they say they don't have time to report success - that's the only way we can differentiate and you can know which one to help.
Forum	general		I have learned the importance of reintegration from the military. Even after the war in Syria, we gave them a slum to live in but it became a slum. Where is the reintegration? We (humans) go back to the easiest pathway. If you put the money into random stuff, and advertise, if you don't have the system to improve, then they won't change mindset. New neural pathways aren't being made if you are not training them for reintegration. I see a lot of the sending the message out there and put the money to make people act. Where is the training? You are taking out the block by reducing barriers.

It was almost like an experiment because now we have to move them and what's going to happen to them? 55 people and no money anymore. Will they be dispersed? Is there money coming from somewhere else? The idea was to create a control to where these people are, but now they will be scattered again.

Forum	general	So many orgs are doing great work. We (Salvation Army) do our best to partner with other orgs. We are blessed with the funding we have now but it's hard. Of course, we need to do better job of sharing the story. Funding is a major part of the issue. We have 74 beds and land. We have been flying under the radar but we continue to serve as best as we can.
Forum	general	My understanding is that 40% are substance abuse/ 48% MH, 12 % is other. I see you supporting a lot of services and how do we cure their addiction? They don't change unless they know they need to change. In my family, there was an individual who was hooked on drugs, he lived in a pretty bad life style but the family cut off assistance to him and eventually he turned his life around. There's another example from a friend I know where they continue to support their addicted family member and that person never changes, it's been 10 years now. How can we change them unless they actually want to? Will this really help? How do we ensure that they will really change?
Forum	general	A housing first model has saved a lot of money in Salt Lake City. Drugs are a psychological issue. They are taking drugs because they are not having their needs met.
Forum	general	I was just going to say that homelessness happens for many different reasons. I have been diagnosed with paranoid schizophrenia when I was 13, I have been off of my medication for 8 years since I had my first child. Everything to help starts with having a roof. You need to house them, then help find the cause that caused them to become homeless
Forum	general	I became homeless because they came and bought up the apartments, a lot of people in Lexington Heights became homeless because the guy bought the apartment and upped the rent. It is not all about drugs, it is not all about gang members. I was not on drugs, I was told in 90 days you have to go. Because of my disability I could not really go to work, and I had nowhere to go. It is not just because people do not want to work.

Forum	general	Everybody don't want to be homeless. I was homeless at one time because I have an aggravated assault charge for a police record thirty years ago and it will not be expunged unless I was pardoned. But everybody don't want to be homeless. That is just like, some people may need something for a cold and some people need something for cancer in terms of the homeless situation. It is a lot going on, a lot of people do not want to be homeless but they have so much going on. Some of them are sick, some of them have AIDS and nobody wants to take them and they have gone into depression. At any time, one of us can be homeless - it can happen to us all. I have a cousin who graduated dental school, she has kids but has fallen into a depression and cannot do anything and it can happen to anybody. I understand that we cannot just hand out money but somebody got to help. Somebody has to start to help the homeless.
